Financial Report presented by Cheryl Joyce:

- Increase in Federal Grant due to UPIP grant recognized year-to-date
- Increase in recognized Alberta Education revenue based on previous amount
- Increase in accrued revenue due to 3% in Oilers funding as per agreement
- Increase in prepaid expenses due to increase in bus tickets
- Decrease in unearned revenue due to decrease in amount received from Alberta Education, increase in Alberta Education payment recognized as revenue, and decrease in deferred donations
- Retained earnings based on preliminary 2018 year end data, not yet final
- Expenses are relatively similar to last year
- Action: Joe Coultier to look into potential resources from the Edmonton Community Foundation to assist in fund development (contact is Andrea Diamond)
- Cory Chan carried forward an idea to use the surplus and include in the budget to spend
- Action: All put forward potential ideas for use of the surplus for next meeting
